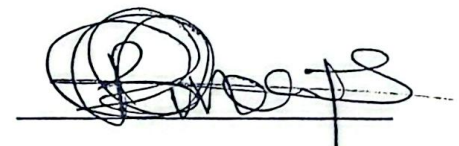
determination of this suit, render or appear to render the Judgment thereon nugatory.

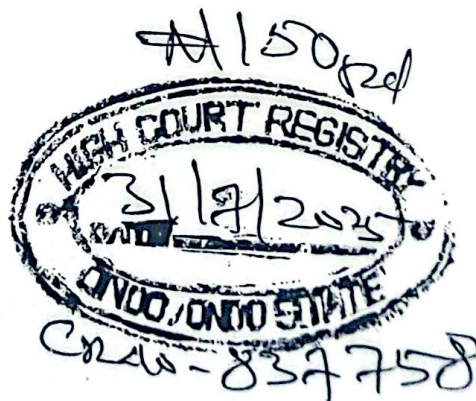
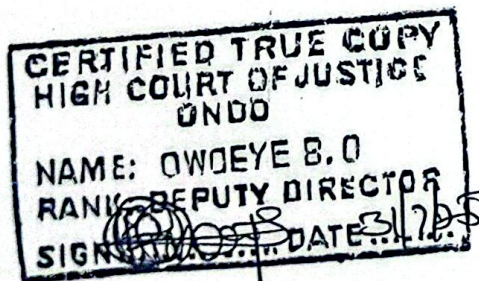

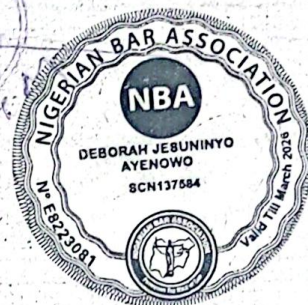
